# **HOUSING LAW CONFERENCE 2023**

Statistics indicate that the BAME communities are disproportionately likely to be homeless, living in temporary accommodation or in deprived neighbourhoods.

How should we, as housing lawyers, respond? Legal reforms will not work if people do not have access to the legal advice and representation necessary to help them enforce their rights. Against this backdrop, it is more important than ever for housing practitioners to join forces to speak up for our clients, share knowledge and experience and support each other.
